## Shipping Requirements for All Vehicle Export Customers

These are the United States Customs requirements which MUST be met:

### **A vehicle is identified as:**

- All cars, trucks
- Motorcycles
- Heavy equipment (anything self-propelled)
- All Terrain Vehicles (ATVs, Go Carts, and anything with an engine over 50cc)
- All other self-propelled items

### **Requirements:**

1. Original Title or MSO signed by the buyer and seller.
2. Original bill of sale signed by the buyer and seller.
3. Export power of attorney. (If the party is not present in the United States the Export Power of Attorney MUST be notarized at either a U.S. consulate or a local Justice of the Peace.)
4. Picture identification (A passport or U.S. issued ID will only be accepted.)
5. Company letter (if vehicle or equipment is in the company's name a company letter will be required).
6. Business license (If the vehicle is in the company's name a copy of the business license must be now must be left on file on the company's letterhead.)
7. All untitled equipment would only require a bill of sale. This MUST be signed by both parties (i.e. the buyer and the seller) and notarized.
8. Any export document packages not in proper order or incomplete will be rejected and returned to the exporter for corrections, and the vehicle will NOT be accepted.
